ONE VOICE WALES TRAINING Biodiversity

Rachel Carter introduced the programme for the day.

Of particular importance to CCC was the expectation of the Welsh Government that community councils prepare a **Biodiversity Action Plan** to encourage the promotion of Eco Systems which should be **published by the end of 2022 and reviewed every three years.** An impressive presentation was given by the Clerk of the Draethen CC. the council had been extremely proactive in engaging their community to improve / inform:

- Road safety
- Ecology of the area
- Improving anti-social behaviour
- Importance of health and wellbeing
- Mountain biker's safety
 - Horse rider's safety

The above was achieved by bringing the community together for curry and consultation evenings, working parties and councillors getting out into the community.

- Signage around the villages was placed in consultation with NCC to address speeding vehicles
- Activities and events were organised to raise awareness of the work of the council
- Fire breaks were placed where fires were consistently lit
- Health walks were encouraged with locals
- Schools were involved e.g. pollinator gardens
- Landowners were involved Bee hives and hides.

Our Council must create a plan proportionate to its size.

What can we do?

Some ideas:

- Walking groups with coffee (community) at the Golf Club
- Dialogue with industries to discover how they are dealing with diversity and health and wellbeing of their staff, e.g. seated areas for relaxation, charging points for cars and involve them in setting the plan.
- Outdoor gym Green Gym
- Painting speed chevrons on Celtic Way
- Requesting the Police to install a noise camera on Celtic Way to identify those cars using it as a race track.

Microsoft Data Centre Public Exhibition 29/9/23

In summary the data centre will be applying for planning late October 2023. The emphasis is on the environment from low level buildings to rainwater harvesting, green energy they have an ambitious energy target to meet by 2030 and this facility will be compliant. There are currently no plans to expand the facility in the future.

Jobs: 35 highly specialised shift jobs will be to operate and maintain the centre, security will be 10 people with 24hr coverage. Concrete blocks are already in place around site to deter unwanted visitors.

Castleton Park Crematorium and Memorial Grounds Public Exhibition 29/9/23

Chosen for its location between Newport and Cardiff the proposed site is to be located off Penylan Road, all funerals are to arrive at the site via the A48 and Coal Pit Lane (some lane widening maybe required for two-way traffic). The emphasis on the site is to provide an unobtrusive, calm natural setting for funerals with NOx abatement (Nitrous Oxide. The site intends to operate between 10:30 hrs to 15:30hrs, forecasts estimate 1000 funerals per year(4/day),20 cars/ funeral, gives 80 cars a day.
