Report relating to the Marshfield and Tredegar House Ward acknowledged by the council.

Actions from **June Meeting**: Camera footage on Celtic Way (the road to nowhere) were accessible to the police if requested).

17. Issues Discussed:

- Grass needs cutting on Church Crescent as it has not been cut since March and could potentially be a fire hazard.
- Ground to the rear of Church Crescent is overgrown and requires cutting back as it is a Public Right of Way.
- The possibility of Newport City Homes placing bollards around the green in Church Crescent to stop car parking on the site.
- Tredegar House play area standard of maintenance is the responsibility of the city council. Query on standards of maintenance.
- Information on the potential siting of a Porsche dealership / hub to the rear of the Dragonfly.
- The Rutherford Centre which was a state-of-the-art provider, was due to be taken over by the NHS but is now closed. Reasons for the closure are being queried by the Ward's NCCs.
- New parking for SCS will accommodate 300 vehicles. Nevertheless, there is no footpath for workers.
- A drain cover by LG and owned by BT is causing a hazard. NCC to look into the issue.
- Zoom to be purchased in time for the next meeting of the council, i.e. 6th September, 2022.
- Permanency of current cameras on Celtic Way to be looked into by the NCCs.

19. Matters arising from the minutes:

19.1 Website

- Dale and Paul to forward bios for the website with the Chair providing an introduction to the area. These and other photographs to be forwarded to the web site designers.

19.2 Zoom

- The committee agreed to proceed with the purchase of Zoom to allow councillors and members of the community to access council meetings.

19.3 Budget

- Discussion took place on the precept which has to be forwarded by the end of December. It was agreed that the precept be set at a higher level, possibly £4 which would be an increase of 50p per household. This would support the current expectations of community councils.

20. Planning:

Porsche Garage which is to be built on Lakeside Drive.

21. Police

- Travellers who arrived on a site near the power station has since moved on
- A query was raised concerning cars which seem to be abandoned on the A48 opposite Berry Hill Farm. The Police agreed to look into it.
- Race meetings along Celtic Way has ceased for the present time. The Police to be contacted in relation to Sound Cameras being installed as a preventative.
- It was raised by a councillor that cars parked / abandoned can be reported to the DVLA and their registration recorded. Concern was raised that these vehicles cause a hazard as they do not allow a clear view for other road users.
- Following a concern raised by Cllr. PT regarding the dangerous crossing on one of the ASDA roundabouts, the Police and the CC would ask the NCC Highways Dept. be asked for a response.
- No problems were reported in the area over Halloween and Bonfire Night.
- Sling shots were used by travellers to cause damage in the Marshfield area.

Action: Clerk to raise road concerns with Inspector Jason Williams, Gwent Constabulary.

22. Issues discussed

- Cllr. DJ raised a concern over noise from Vanguard when moving materials into skips. NCC AS passed on the concern to NCC Environmental Health, visited the site and this, with action by Cllr. DJ, resulted in the skips being removed.
- Porsche has been granted permission for 2 showrooms to be built on Lakeside Drive opposite a number of small businesses. Porsche are leasing the land. Concern was raised on the potential use of Celtic Way for test driving which has happened in the past.
- DPD drivers using the lanes around the Coedkernew area are still causing concern with their poor attitude to the speed limit.
