3. Minutes of previous meeting

Minutes of previous meeting on 2nd September 2024 accepted as a true record.

4. Matters Arising

Duplication of Road Names: It transpires that the duplication of Celtic Way, road naming was down to Welsh Assembly Government legacy and part of their plans to extend the A48/SDR. Until this is resolved residents are requested to use the "What Three Words" app to report any issues on Celtic Way.

Fly Tipping: A fly tipping workshop has been arranged at Marshfield Village Hall. All Councillors are encouraged to attend.

This is an ongoing issue across the Wentloog Levels, there are cameras sited at hotspots, unfortunately they are jammed, found and destroyed. NCC currently has 40 cases in the court system.

Vantage Data Centre Inconsiderate Working Hours: Building CWL1 currently has no planning applications, NCC will now open a case to investigate. The substation: more land has been cleared than stated on the planning application – NCC to review. The noise over the weekend continues starting at 7am on a Sunday morning, where residents as far away as Blacksmiths Way heard the cable pullers shouting "Pull!". Windows and cars are filthy due to the groundwork, window cleaners were promised to the residents, but nothing has happened. The work on the bund has not been completed, we are now in tree planting season. Residents are now concerned as they cannot sell their houses with the high levels of dirt and noise emanating from CWL1. Directors are no longer responding to emails sent by residents.

5. Newport City Councillors Report

NCC Cllr T Watkins gave a report, an ESTYN inspection has been carried out in NCC, all Schools are rated good with none in special measures and no reviews. Social Services; no outstanding issues. An extra £600K is needed for the leisure centre, extra funding of £600K to education. Cleaning of the footbridge in Coedkernew, the Cenotaph and the Civic Clocktower has started. A project is in to repair the leaking

roof on the clock tower, unfortunately the funds generated by using the building as a film set has gone elsewhere. Grass collections are now every three weeks, the last on 6th November. The centre verge on Celtic Way needs a litter pick before the verge is cut.

We have just had our quarterly finance meeting no issues reported. The Clerk and Chair attended the Community Council Liaison Meeting training session on Safety. There is £6225 in the bank, with no new expenses to be paid.
