1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £ 0 under section 137. These payments are included within 'Other payments' in the Accounting Statement.




Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Coedkernew Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Annual Governance Statement

I am unable to conclude whether or not the Annual Governance Statement is consistent with the Council's internal controls and governance arrangements for the year:

- Assertion 1 and 4: approval of accounting statements and exercise of electors' rights. The Council did not make proper arrangements for the approval of the accounts in line with the timetable and requirements set in the Accounts and Audit (Wales) Regulations 2014.
- Assertion 2: The Council did not maintain an adequate system of internal control during the year and the response is inconsistent with the conclusions reported by the Internal Auditor.
- Assertion 3: The Council has not provided evidence that it submitted to the Independent Remuneration Panel for Wales (IRPW) a schedule of payments made to members.


Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Negative assertions

The Annual Governance Statement sets out the expected minimum standards for local councils. We draw your attention to the Annual Governance Statement whereby the Council has stated a negative response to multiple assertions. We recommend that the Council makes the necessary improvements to its arrangements to address the deficiencies it has identified, when the Council has stated a negative to response within the Annual Governance Statement the Council must make appropriate disclosures within the annual return as to why it has made the negative assertions.

There are no further matters I wish to draw to the Council's attention.
